Your My Funky Rewards Membership is subject to this agreement, which comprises Section A - Membership Terms of Service and Section B - relevant Benefit Specific Terms of Service together with the additional terms and information contained in:

1. Your Membership Pack; and
2. the Funky Pigeon Privacy and Cookies Policy
3. any applicable Benefit Specific FAQs

Together these documents form your agreement (the "Agreement") with us.

In the event of any conflict between the above terms, the terms shall apply in the following order: (i) Section A; (ii) Section B; and (iii) FP Privacy and Cookies Policy.

Where the Benefit Specific Terms of Service in Section B refer to our third party supplier's terms of use (e.g. in relation to Gift Cards), you will need to ensure that you read such terms as they will also apply to you.

It is important that you read all of the documents forming your Agreement carefully since they contain important information about your My Funky Rewards Membership, including your rights and obligations.

Please save/print a copy of your documents and keep them together and in a safe place in case you need to refer to them in future.

Your My Funky Rewards Agreement is made between: You ("you" or "Member"); and funkypigeon.com Limited, Greenbridge Road, Swindon, Wiltshire, UK SN3 3RX (Registered No. 06208854) ("FP", "us" or "we").

Payment of the Membership Fee or acceptance or use of the My Funky Rewards Membership Service and the receipt of any of the specific benefits will constitute the Member's acceptance of all of the terms and conditions of this Agreement.

By entering into this Agreement with FP, you will become a Member of the My Funky Rewards programme ("My Funky Rewards Programme").

## GLOSSARY OF KEY TERMS

- **Benefit Specific FAQs;** all and any FAQs referred to within the Benefit Specific Terms of Service;
- **Benefit Specific Terms of Service;** the benefit specific Terms of Service set out in Section B of these Terms of Service;
- **FP:** funkypigeon.com Limited, Greenbridge Road, Swindon, Wiltshire, UK SN3 3RX
- **Funky Pigeon Prepay Account:** Member's online funkypigeon.com account
- **Gift Cards:** includes both Gift Cards and Gift Vouchers
- **Items:** the goods and/or services you purchased;
- **Member:** a person resident of the United Kingdom who has joined the My Funky Rewards programme;
- **Membership Fee;** the monthly fee payable by Member using a UK registered credit or debit card during his membership. The period and amount of this fee will be notified during the enrolment process and confirmed to Member in the Membership Pack;
- **Membership Pack;** the information pack you will receive from FP by email or post after enrolling in the My Funky Rewards Programme and which contains the start date of your membership, details of the Membership Fee together with other important information relating to your membership.

- **My Funky Rewards Membership Service:** the right to participate in the My Funky Rewards Programme, and earn and receive cashback and other benefits as described in clause 1 below;
- **My Funky Rewards Programme:** the My Funky Rewards programme operated by FP;
- **Retailers:** the third party suppliers that offer goods and services on the Website;

# SECTION A: MEMBERSHIP TERMS OF SERVICE

## 1. MEMBERSHIP SERVICE DESCRIPTION

---

As a Member of the My Funky Rewards Programme, FP grants you the right to: earn cashback; purchase discounted Gift Cards and to earn, or receive other benefits. Collectively, the right to participate in the My Funky Rewards Programme and the right to earn and receive cashback and other benefits is referred to as the My Funky Rewards Membership Service. The specific benefits of the My Funky Rewards Membership Service are always subject to availability and change. The Member should check the Website or contact the Customer Service team (see contact information above) in order to check whether a particular benefit is available at a given time.

## 2. YOUR ELIGIBILITY

---

In order to receive the My Funky Rewards Membership Service and to qualify for any benefits associated with the My Funky Rewards Membership Service, Member must be 18 years or older, a resident of the United Kingdom with a UK registered credit or debit card and a UK bank account/IBAN. FP reserves the right, at its sole discretion, to refuse any person from becoming a Member. Members may join the FP Rewards Programme via the [FP website](#).

Any individual may only hold one Membership in the My Funky Rewards Programme at a time. Member agrees that the My Funky Rewards Membership Service may only be used for his/her own personal benefit. Membership of the My Funky Rewards Programme is not transferable. If a Member has more than one My Funky Rewards Membership and/ or a Member fails to comply with any provision of this Agreement, FP reserves the right to terminate all memberships and in such case any accrued benefits and/or cashback earned in respect of all the cancelled memberships, but not paid at the date of termination, will be forfeited.

The bank account details/IBAN you provide to receive your benefit must only be used by you. If your bank account number/IBAN is being used by another Member, the Membership which was created later will be terminated and any accrued benefits not paid at the time of termination will be forfeited. If FP suspects these accounts have been created for misuse or fraudulent activity, FP reserves the right to terminate all accounts using the same bank account number/IBAN and any accrued benefits not paid at the time of termination will be forfeited.

Members must be a living individual; no machines, scripts or automated services may be used to accumulate financial benefits derived from Membership and use of the My Funky Rewards Programme..

### **3. MEMBERSHIP AND USE**

---

Provided that the Member complies with the requirements set out in these Terms of Service, FP agrees to provide the My Funky Rewards Membership Service to the Member for the term of this Agreement. FP will endeavour to make the Website available 24 hours a day, 7 days a week.

However, there may be times when FP is unable to make the Website available for technical, operational reasons, such as scheduled maintenance shutdowns, or for other commercial reasons. Any printed material and software provided by FP to the Member is the exclusive property of FP.

Members are required to use the My Funky Rewards Membership Service in accordance with these Terms of Service and in an honest and ethical manner.

Member is responsible for his or her use of the My Funky Rewards Membership Service and must promptly notify FP of any unauthorised use of the My Funky Rewards Membership Service. Member agrees not to publish, retransmit, broadcast or otherwise reproduce in any medium any information or software that is made available to Member other than for the purpose of receiving the My Funky Rewards Membership Service.

To gain access to the Website Members must have Internet access, an email address, a user name and a password. Member agrees to keep Member's user name and password private so that they cannot be used by any other person. FP will not be liable for any damages, losses or expenses suffered by Member or any third party as a result of any unauthorised person gaining access to any of the "Member only" areas of the Website where FP is not at fault.

We would like to draw your attention on the fact that, as part of your MFR Membership, we may use the services of financial institutions or bank's subcontractors, subject to legal reporting requirements. In such circumstances these financial institutions or bank's subcontractors may carry out identity, credit reference and fraud prevention checks before any financial transaction is processed, including whenever we would process the payment of your benefits. Any information, which is processed by way of transfer to said financial institutions or bank's subcontractors, is intended for this specified purpose only. Please note that such credit reference and fraud prevention agencies may disclose the fact that a check was made for the purposes of fraud prevention.

We may ask you to provide us with a copy of your proof of identity (ID/passport) as well as some additional information such as date and place of birth, address, phone number and UK bank statement. We inform you that your failure or refusal to provide the information requested will prevent us from providing the benefits of the membership and may result in the termination of your membership. There may also be some delay to us commencing delivering of your benefits to you as a result of these checks.

## **4. MEMBERSHIP FEE**

---

The Membership Fee, as notified during the enrolment process and confirmed to Member in the Membership Pack and in monthly email communications from FP, will be charged on a monthly basis (unless set out otherwise during the enrolment process). Payment of the Membership Fee will entitle Member to continue his or her Membership of the My Funky Rewards Programme and to receive the My Funky Rewards Membership Service. The Membership Fee will be billed automatically by an authorised third party bill payment firm which holds and receives the Membership Fee for and on behalf of FP (known as a "Bill Payment Firm") to Member's credit or debit card (each a "Billing Device") unless the agreement is cancelled or terminated by Member or FP. FP may from time to time change the Membership Fee and will give you at least 30 days advance notice before doing so. In the event of any such change your attention is drawn to your general right of termination as set out below.

Payment of the Membership Fee to Webloyalty International Sarl will entitle Member to continue his or her Membership of the My Funky Rewards Programme and to receive the My Funky Rewards Membership Service. Payment of your membership fee to Webloyalty International Sarl discharges you of any obligation to make payment of the fee to us. Your statement may show the Membership Fee as collected by Webloyalty International Sarl or include the acronym "WL".

FP may from time to time change the Membership Fee and will give you at least 30 days advance notice before doing so. In the event of any such change your attention is drawn to your general right of termination as set out below.

The Membership Fee is inclusive of VAT.

## 5. TERM

---

This Agreement shall enter into force on the effective date of the Member's membership in the My Funky Rewards Programme, for an initial period of thirty (30) days ("Initial Period"), unless otherwise limited on the subscription pages. Member expressly agrees on enrolling into the My Funky Rewards Programme to receive the benefits of the Programme immediately.

Depending on what is mentioned on the subscription pages of the My Funky Rewards Membership Service (and confirmed thereafter in the Membership Pack), the Member may (or may not) be required to pay a monthly Membership Fee.

- If the Initial Period is free: Member has the right to cancel the Agreement at any time up until 30 days from the start date of this Agreement without giving a reason or paying any Membership Fees (this Initial Period includes the legal right to cancel the Agreement at any time up until 14 days from the start date of this Agreement (the cooling off period) without giving a reason or paying any fees). A cancellation form is provided at the end of these Terms of Service and can be downloaded by clicking here.
- If the Initial Period is not free: Member has the legal right to cancel the Agreement at any time up until 14 days from the start date of this Agreement (the cooling off period) without giving a reason and will be entitled to a refund of any fees paid. On the expiry of 14 days, Member can still cancel the Agreement during the Initial Period but will not be entitled to a refund of his first Membership Fee paid.
- After the Initial Period, this Agreement will be automatically renewed for successive periods equal to the Initial Period (i.e. 30 days) - and
  1. the Member has exercised his legal right of cancellation within fourteen (14) days (the cooling off period) or any relevant trial period, and /or
  2. If the Initial Period is free, the Member has exercised his right of cancellation within this Initial Period and /or
  3. FP has informed him of its intention not to renew the contract when due, and /or
  4. the membership was terminated earlier, in accordance with the Termination section

The Agreement shall terminate on the last day of the Initial Period or relevant 30 day period during which either party terminates the Agreement, except as set out in the Termination section.

## 6. CANCELLATION AND TERMINATION

---

### 6.1 CANCELLATION OR TERMINATION BY THE MEMBER

The Member can cancel your membership at any and time without having to justify the reason by notifying FP in the following ways:

- **Online** via the online cancellation service (available through the [Profile](#) area of the Website when the Member is logged in).
- **Email:** at [customerservice@myfunkyrewards.com](mailto:customerservice@myfunkyrewards.com)
- **Phone:** by calling our Customer Service Representatives to the phone numbers set out in the page "[Contact us](#)" (Monday to Friday 8am-8pm, and Saturday 9am- 4pm).
- **In writing** either write to FP or download and send the cancellation form featured at the end of these Membership Terms and send this to: My Funky Rewards, Sentinel House, Airspeed Road, Portsmouth, Hampshire, P03 5RF

A Member who terminates his membership shall have the right to use and receive all the benefits of the My Funky Rewards Membership Service for the rest of the current 30-day period. At the end of the said period, the termination will take effect and the Member will no longer have access to the My Funky Rewards Membership Service, nor any obligation to pay any further Membership Fee..

## 6.2 TERMINATION BY FP

FP has the right to terminate the membership of a Member at any time and for any reason on thirty (30) days written notice and in this case FP shall reimburse the member the Membership Fee for the current 30 day period, prorated for the portion of the remaining period as the case may be. The Member shall immediately cease using or receiving all the benefits of the My Funky Rewards Membership Service as from the effective date of termination. The notification will be sent to the email address provided by the Member. FP will not be responsible for any non-receipt of notice by Member where such failure is caused by any reason outside the reasonable control of FP, including, but not limited to non-receipt due to: an error in your email address, an inaccurate email address; your failure to check your email online; your failure to inform FP of a change in your email address; or a failure of the Internet. In addition, FP has the right to immediately terminate this Agreement for breach by the Member of its obligations under this Agreement. FP also has the right to terminate any membership with immediate effect if: the e-mail address or mailing address provided by the Member is no longer valid; if the Member has provided an invalid payment method when s/he subscribed; or if the means of payment provided by the Member becomes invalid or expires during this Agreement. An invalid payment method would include, for example, a lost or stolen credit card, a bank card that cannot be charged (fenced bank account or bank account where overdraft limit has been reached, for example) or an invalid credit card number.

FP also reserves the right to immediately terminate any membership for any misuse or fraudulent activity, any extraordinary activity which suggests fraudulent use beyond personal and domestic use of the My Funky Rewards Membership Service, for example and not exhaustively, including, where a trial period for the My Funky Rewards Membership Service is offered to the Member, if he subscribes several times to the My Funky Rewards Membership Service and terminates before the end of the trial period, thus benefiting from the service several times without paying a Membership Fee. Similarly, if a Member has made purchases for non- personal use or attempts to obtain benefits through the My Funky Rewards Membership Service for purchases made by

another person or that s/he falsified supporting documents. Additionally, exceptional levels of cancelled orders and/or exceptional levels of returned may be deemed misuse and result in termination of your membership.

In case of immediate termination of this Agreement at the request of FP, FP has the right to immediately terminate the payment of all accrued benefits without any right for the Member to reclaim them or any other compensation. To enable FP to carry out investigations into the validity of any Member activity, Member may be required to provide evidence of identification and/or of Items. Such evidence may include proof of delivery address, Member's address and/or copies of all relevant purchase receipts or such other evidence as FP may reasonably request from time to time.

A cancelling Member may not re-enrol in the My Funky Rewards Membership Service for at least six (6) months. If any additional memberships are detected during this six month period by way of name and/ or address, email, payment details and/or bank account/IBAN they shall be cancelled and any accrued benefits shall be forfeited.

## **7. CHANGES TO YOUR AGREEMENT**

---

FP may revise these Membership Terms of Service from time to time. FP will only make changes where FP has a valid reason to do so. Where FP are able to do so, FP will notify you regarding any material changes to the My Funky Rewards Membership Services, your Agreement or the fees and will give you at least 30 days advance notice before making any such change. In the event of any such changes your attention is drawn to your general right of termination as set out above. FP will notify Member by notice on the Website or by email if revised Membership Terms of Service apply. Members are encouraged to read any revised Membership Terms of Service.

## **8. LIABILITY**

---

### **8.1 RETAILERS**

FP may be the provider of the My Funky Rewards Membership Service, but the goods and services purchased ("Items") by Member through the Website of FP are provided directly by third party suppliers (each referred to as "Retailers") to Member and such purchases will be subject to the relevant Retailer's terms and conditions of sale. Member acknowledges that, in such circumstances, FP has no control over the quality, safety or legality of Items advertised by retailers, the truth or accuracy of the listings or the ability of retailers to sell the Items and that orders placed by Members through use of the My Funky Rewards Membership Service and communicated to Retailers are offers by Members to purchase Items from such retailers. FP cannot and does not control whether or not Retailers will accept such offers or complete the sale of the Items they offer. With respect to Items provided by Retailers, FP will have no liability to Member arising out of: (i) the failure of any participating Retailers of any Items to supply any such Items on the terms offered; (ii) any delay in delivery of any Items, regardless of the cause of such delay, or (iii) any defective or nonconforming Items.



## 8.2 MY FUNKY REWARDS MEMBERSHIP SERVICE & LIMITATION OF LIABILITY

FP does not guarantee that Member's access to the Website, or any content on it, will be uninterrupted, timely, secure or error-free. FP may suspend or withdraw or restrict the availability of all or any part of the Website for business and operational reasons. FP will try to give you reasonable notice of any suspension or withdrawal. FP agrees to take reasonable steps to prevent the introduction of viruses or other destructive materials to Website. FP do not guarantee that the Website is entirely free of destructive material and FP excludes all liability in this respect unless (and to the extent) attributable to its breach or negligence.

We are responsible to you for foreseeable loss and damage caused by FP. If we fail to comply with these Membership Terms of Service, we are responsible for loss or damage you suffer that is a foreseeable result of our breaking this Agreement or our failing to use reasonable care and skill, but we are not responsible for any loss or damage that is not foreseeable. Loss or damage is foreseeable if either it is obvious that it will happen or if, at the time the contract was made, both we and you knew it might happen, for example, if you discussed it with us during the sales process.

Subject to the paragraph below, FP's total liability to you in respect of the My Funky Rewards Membership Service shall be limited to the amount equal to the Membership fees payable by you in any twelve month period under your Agreement.

We do not exclude or limit in any way our liability to you where it would be unlawful to do so. This includes liability for death or personal injury caused by our negligence or the negligence of our employees, agents or subcontractors; for fraud or fraudulent misrepresentation; for breach of your statutory legal rights in relation to this Agreement.

We are not liable for business losses. We only supply the My Funky Rewards Programme for domestic and private use. If you use your membership for any commercial, business or re-sale purpose, you will be in material breach of these Terms of Service and we will have no liability to you for any loss of profit, loss of business, business interruption, or loss of business opportunity.

If FP's supply of the My Funky Rewards Programme is delayed or prevented by an event outside of FP's control then FP will try and contact you as soon as is reasonably possible to let you know and FP will take steps to minimise the effect of the delay. Provided FP do this FP will not be liable for delays caused by the event, but, in any case, you may contact us to cancel your membership in accordance with clause 6.1 should you wish to do so. Examples of events which are outside of FP's control include (without limitation) war, terrorism, cyber-attack, invasion, an act of foreign enemy, hostilities (whether war be declared or not), riot, strike, civil commotion, civil war, revolution, insurrection or military or usurped power.

Nothing in these Terms of Service will affect your legal rights. Please refer to your local Citizen's Advice Bureau or local trading standards office for further information about your statutory rights.

## 9. COMMUNICATIONS

---

Member hereby authorises FP to deliver any and all communications (“Communications”), including but not limited to Membership information, procedures on use of the My Funky Rewards Membership Service, changes in the My Funky Rewards Membership Service benefits, and change in the Membership Fee to Member’s electronic mail address or postal address at FP’s discretion. Member further authorises FP to deliver any Communication by sending in lieu of such Communication (the “Underlying Communication”), a notice that directs Member to a webpage where the Underlying Communication is posted. Member agrees that the sending of a notice of delivery by Web posting shall constitute delivery whether or not Member actually accesses the Underlying Communication via the Web. Member agrees that s/he will not, for any reason, alter any Communication delivered electronically or otherwise. FP does not guarantee Web access; however FP offers Member various ways of communicating with its customer service staff (see Customer Services Contact Information above).

## 10. TAXES

---

The Membership Fee is inclusive of all applicable taxes.

## 11. USE OF INFORMATION

---

To understand what data we collect about Members, how this is used, who it is shared with and Members’ rights associated with their data, see our [Privacy and Cookies Policy](#).

Bank/card issuer will pass your name, address, date of birth and card details to us for the purpose of providing the Webloyalty Membership Service and billing your account with the fees. From time to time we may ask your card issuer to update us with any changes to the information they have provided to us, for example by providing us with any updated or new card numbers or expiry dates. Please see our Privacy and Cookies Policy for more information.

We record and monitor calls by you to our customer service desks. We will process your data for legitimate business purposes namely quality assurance and training purposes and to ensure we have collected and recorded any consent you provide over the phone.

## 12. ENTIRE AGREEMENT

---

Member acknowledges that use of any particular benefit may be subject to additional terms and conditions (“Benefit Specific Terms of Service”). This Agreement, including these Terms of Service, the Benefit Specific Terms of Service, the Membership Pack and Benefit Specific FAQs, constitute the entire understanding and Agreement of the parties with respect to the subject matter hereof and will supersede any and all prior oral or written communications, representations or agreements.

## **13. GENERAL**

---

If any provision of your Agreement is found by any court or administrative body of competent jurisdiction to be invalid or unenforceable, such invalidity or unenforceability shall not affect the other provisions of your Agreement which shall remain in full force and effect. Any omission to exercise, or delay in exercising, any right or remedy under this Agreement shall not constitute a waiver of that, or any other right or remedy. The waiver by any party to this Agreement of any of its rights or remedies arising under this Agreement or by law shall not constitute a continuing waiver of that right or remedy or a waiver of any other right or remedy.

## **14. NOTICE**

---

Member must notify WL of any change to his/her address, electronic mail address and/or Billing Device.

Customer Services Contact Information is set out above and is also available on the Website.

## **15. ASSIGNMENT**

---

This Agreement may be assigned in whole or in part by FP at any time in its discretion. This Agreement may not be assigned by Member without FP's prior written consent.

## **16. GOVERNING LAW AND DISPUTES**

---

This Agreement (including the Membership Pack, the Benefit Specific Terms of Service, the applicable Benefit Specific FAQs and Privacy & Cookies Policy), will be governed by and construed in accordance with the laws of England and Wales. Member agrees to settle any disputes regarding retailer's Items directly with the applicable retailer and not involve FP in a dispute between Member and a retailer.

## **17. DISPUTES AND THE EC ONLINE DISPUTE RESOLUTION PLATFORM**

---

If you have a dispute with FP we will try to resolve it quickly and efficiently. If you are unhappy with our service to you please contact us as soon as possible. If you and we cannot resolve a dispute using our internal complaint handling procedure we will let you know that we cannot settle the dispute with you and provide you with details of an Alternative Dispute Resolution (ADR) provider and outline our intentions on using them.

You may register your complaint using the European Commission Online Dispute Resolution (ODR) Platform. This is a web-based platform that is designed to help consumers who have bought goods or services online to deal with issues arising from that purchase. Complaints submitted to the platform will be dealt with by approved ADR providers. You can access the platform at the following website address: <http://ec.europa.eu/consumers/odr/>

## **18. ENGLISH LANGUAGE**

---

The parties hereto have requested that this Agreement and all correspondence and all documentation respecting this Agreement be written in the English language.

## **19. RIGHTS OF THIRD PARTIES**

---

This Agreement does not confer any rights on any person or party (other than FP and the Member) under the Contracts (Rights of Third Parties) Act 1999.

## **20. INTELLECTUAL PROPERTY RIGHTS**

---

You acknowledge that all copyright, trade marks, and other intellectual property rights, in and relating to the My Funky Rewards Programme are owned by us, or licensed to for us to use. You may not copy, distribute, modify, show in public or create any derivate works from any material which is found on this Website or in any communications from us.

# **SECTION B: BENEFIT SPECIFIC TERMS OF SERVICE**

## **21. WELCOME REWARD**

---

1. Members of the My Funky Rewards Programme are entitled to claim a Welcome Reward (“Welcome Reward”), which is offered to Members when they successfully enrol in the My Funky Rewards Programme. Further details and conditions relating to the Welcome Reward can be found via the ‘Member Benefits’ link on the footer of the Website and within the My Account section of the Website.
2. The Welcome Reward will be credited into the Member’s Funky Pigeon Prepay Account and is to be redeemed on [funkypigeon.com](http://funkypigeon.com). It is not transferable to any other retailers.

## 23. CASHBACK REWARDS

1. An index of the retailers offering cashback via the Website ("Retailers") is provided by FP on the Website. FP is not responsible for changes to, or discontinuance of, any retailer, or any retailer's withdrawal from the My Funky Rewards Programme, or for any effect on accrual of cashback caused by such changes, discontinuance, or withdrawal. FP is not responsible for changes to, or discontinuance of any special offer or coupon code. It is the Member's responsibility to make sure that all special offers are valid. If you choose to use coupons and specials that not listed on the Retailer landing page, FP cannot guarantee that you will be eligible to receive cashback on your purchases.
2. Subject to the cashback limits set out in on retailer's landing page, you will be credited a percentage of the net purchases made by you at each of the relevant retailers. The net purchase is defined as the total amount paid to the retailer minus tax, gift wrapping, shipping, promotional credits, returns, cancellations, and transaction fees or as the retailer defines on their respective website.
3. As a Member, purchases made through a retailer will be deemed a "Qualifying Purchase" and will result in the right to earn cashback if and only if all of the following criteria are satisfied:

Any alteration of these links will invalidate your purchase, which will not be deemed a Qualifying Purchase.

4. There is a maximum eligible cashback amount (“Cashback Maximum”) of two hundred and fifty pounds (£250) for all Qualifying Purchases made online in any calendar month during your Membership of the My Funky Rewards Programme. 15. Cashback Disputes: All questions or disputes regarding the Cashback Reward benefit including without limitation, questions or disputes regarding eligibility for the Cashback Reward, or the eligibility of discounts for
